HSvu End User License Agreement

The HighScore view application ("HSvu app") from Malvern Panalytical made available through the Mac App Store and the App Store (collectively, the "App Stores") is licensed, not sold, to you. Your license to the HSvu app is subject to your prior acceptance of this End User License Agreement ("EULA"), and you agree that the terms of this EULA will apply to the HSvu app. Your license to the HSvu app under this EULA is granted to you by Malvern Panalytical B.V. (the "Malvern Panalytical"). Malvern Panalytical reserves all rights in and to the HSvu app not expressly granted to you under this EULA. You understand that Apple is not a party to this agreement other than as stipulated under article 10 of this EULA.

1. Scope of License. This license granted to you for the HSvu app by Malvern Panalytical is limited to a nontransferable license to use the HSvu app on any Apple-branded products running iOS (including but not limited to iPad, iPhone, and iPod touch) ("iOS Devices") or Mac OS X ("Mac Computers"), as applicable (collectively "Devices") that you own or control and as permitted by the Usage Rules set forth in the Mac App Store, App Store and iBooks Terms and Conditions (the "Usage Rules"). This license does not allow you to use the HSvu app on any Device that you do not own or control, and, except as provided in the Usage Rules, you may not distribute or make the HSvu app available over a network where it could be used by multiple devices at the same time. You may not rent, lease, lend, sell, transfer, redistribute, or sublicense the HSvu app and, if you sell your Mac Computer or iOS Device to a third party, you must remove the HSvu app from the Mac Computer or iOS Device before doing so. You may not copy (except as expressly permitted by this license and the Usage Rules), decompile, reverse–engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the HSvu app, any updates, or any part thereof (except as and only to the extent that any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by the licensing terms governing use of any open–sourced components included with the HSvu app). Any attempt to do so is a violation of the rights of Malvern Panalytical and its subsidiaries. If you breach this restriction, you may be subject to prosecution and damages.

IT IS A CONDITION OF THIS LICENSE THAT THE HSVU APP IS NOT USED IN THE OPERATION OF NUCLEAR FACILITIES, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL SYSTEMS, LIFE SUPPORT MACHINES, DEVICES, APPLIANCES OR SYSTEMS, MEDICAL SYSTEMS OR OTHER EQUIPMENT IN WHICH THE FAILURE OF THE HSVU APP COULD LEAD TO DEATH, PERSONAL INJURY, OR SEVERE PHYSICAL PROPERTY OR ENVIRONMENTAL DAMAGE.

The terms of this license will govern any upgrades provided by Malvern Panalytical that replace and/or supplement the original HSvu app, unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

2. Consent to Use of Data. You agree that Malvern Panalytical may collect and use technical data and related information—including but not limited to technical information about your device, system and application software, and peripherals—that is gathered periodically to facilitate the provision of software updates, product support, and other services to you (if any) related to the HSvu app. Malvern Panalytical may use this information, as long as it is in a form that does not personally identify you, to improve its products or to provide services or technologies to you.

3. Termination. The license is effective until terminated by you or Malvern Panalytical. Your rights under this license will terminate automatically without notice from Malvern Panalytical if you fail to comply with any term(s) of this license. Upon termination of the license, you shall cease all use of the HSvu app and destroy all copies, full or partial, of the HSvu app.

4. Sources; Services; Third-Party Materials. The HSvu app generates data based upon (and is therefore depending on) input from sources outside the HSvu app (collectively and individually "External Sources"). You understand that the HSvu app is only intended for ease of reference and that any decision to act or omit should be based upon the outcome of the External Sources directly and not on the data generated by the HSvu app. Nevertheless, if you decide to act or omit based upon the outcome of the HSvu app, you agree that you do so at your sole risk and that neither Malvern Panalytical nor its agents shall have any liability for such decision or any consequences related thereto.

6. Limitation of Liability.

(1) Except as set out in section (2) hereunder, in no case shall Malvern Panalytical, its directors, officers, employees, affiliates, agents, contractors, principals or licensors be liable for any loss or damage caused by Malvern Panalytical, its employees or agents where:

(i) there is no breach of a legal duty of care owed to you by Malvern Panalytical or by any of its employees or

agents; (ii) it is not a reasonably foreseeable result of any such breach;

(iii) any increase in loss or damage results from breach by you of any term of this EULA;

(iv) it results from a decision by Malvern Panalytical to warn you, to suspend or terminate your access to the External Sources and Services, or to take any other action during the investigation of a suspected violation or as a result of Malvern Panalytical's conclusion that a violation of this EULA has occurred;

9. Applicable law; Dispute Resolution; Severability. All matters arising out of or in connection with this license will be governed by and construed in accordance with Dutch law. This license shall not be governed by the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded. All disputes arising in connection with this license, which cannot be resolved amicably, shall be finally resolved by arbitration in accordance with the Rules of Arbitration of the International Chamber of Commerce. There shall be one arbitrator and the language of the arbitration shall be English. Venue shall be Amsterdam. If for any reason any provision or portion of this EULA is found or held to be unenforceable, the remainder of this EULA shall continue in full force and effect.

10. Entire Agreement; Third Party Beneficiary. This EULA constitutes the entire agreement between the parties with respect to the use and/or operation of the HSvu app licensed hereunder and supersedes all prior or contemporaneous understandings regarding such subject matter. In the event of a conflict between a term of this EULA and the term of any other agreement with respect to the use and/or operation of the HSvu app licensed hereunder, the term in this EULA shall prevail. No amendment to or modification of this license will be binding unless in writing and signed by Malvern Panalytical. You acknowledge and agree that Apple and its subsidiaries are third party beneficiaries of this EULA and that upon acceptance of this EULA, Apple will have the right (and will be deemed to have accepted the right) to enforce the EULA against you as a third party beneficiary hereof.
